The aims of the Trust, which has Charity status, is to provide funding for projects and maintenance to the Church building fabric, inside and out, as instigated by and under the supervision if the Parochial Church Council of All Saints' Church, Staplehurst, the PCC.

The major overhaul of the Church Organ has been completed. We contributed £6603.47 towards the work. In 2017 we reimbursed the PCC £4992.32 which included organ tuning, heating repairs & servicing, periodic electrical safety testing and roof repairs.

Projects which require funding now and in the near future include:

- Further investigation and remedial work regarding the problem with the settlement/sinking in the chancel/choir stalls floor.
- The external stonework of the East end of the church needs repointing and once this is completed the plaster on the inside of this wall will need repair/replacement and redecorating.
- Ongoing roof/leadwork and guttering repairs.

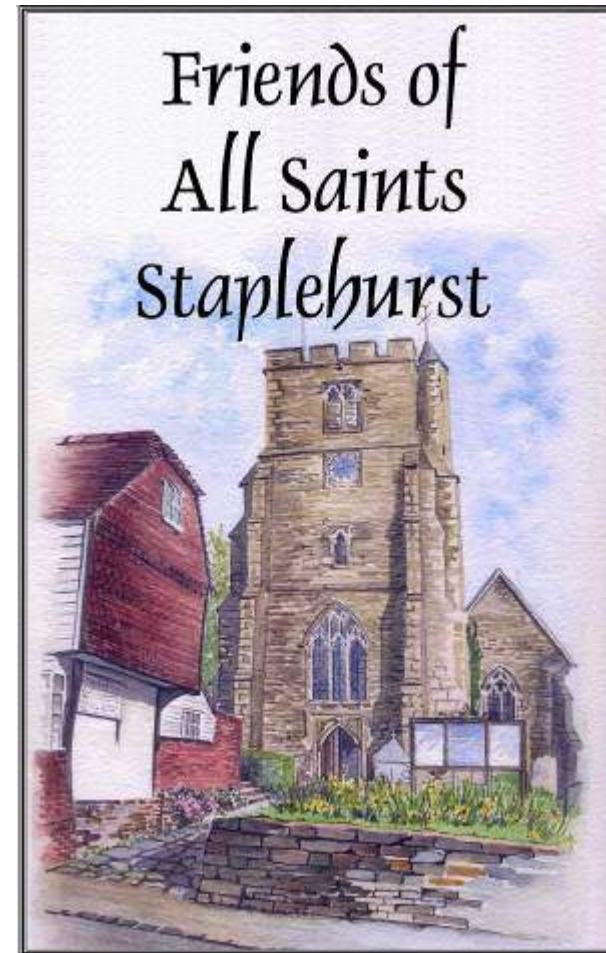
